Following up on our conversation earlier today and last week:

- 1- Station WKZD is operating with the attached licensed operating parameters.
- 2- The pending June 2020 license application, BML-20200602AAM, which you asked about, was filed, as set forth in the application, pursuant to FCC Rule 73.1690(c)(9), solely to change status from a commercial station to a non-commercial educational station, and specifically stated that no technical changes were requested.
- 3- Accordingly, to the extent technical information is desired, as you grant the pending application, the licensee requests that the FCC use the existing licensed parameters, attached, for that application.
- 4- It is respectfully requested that the application be approved as it is consistent with FCC procedures for applications filed under 73.1690(c)(9) solely requesting change in status without change in technical facilities. As a recent example, a change in status license application (BML-20200519AAP) simply referencing no change in facilities, and without a completed technical Section III, was filed May 19, 2020, for AM Station WQRX, fac. id.60648, and was granted on June 26, 2020, in conjunction with an assignment of license.
