Fourth Amendment

ION Media Networks, Inc. ("ION"), Scripps Media, Inc. ("Scripps"), and INYO Broadcast Holdings, LLC ("INYO"), hereby file this fourth amendment to pending applications seeking Commission consent to the transfer of control of certain licenses from ION to Scripps and the assignment of certain other licenses from ION to INYO ("Applications"). The purpose of the instant amendment is to describe minor changes to the attributable interest holders in INYO, none of which result in a change of the ultimate control of the stations that will be acquired by INYO. In addition, by this amendment, the parties confirm that Scripps, not INYO, will acquire WPPX-TV (Wilmington, DE), KKPX-TV (San Jose, CA), and KPXM-TV (St. Cloud, MN).

1. The Applications provided that the licenses assigned from ION to INYO would be assigned to INYO Broadcast Holdings LLC. Subsequent to the filing of the Applications, INYO created a wholly-owned subsidiary of INYO Broadcast Holdings LLC—INYO Broadcast Licenses LLC—to which the licenses will now be assigned. The parties hereby amend Section 5.ii of the Comprehensive Exhibit to the Applications to insert the following chart:

3. The Applications provided that the sole attributable interest holders in INYO Investors LLC were John G. Chachas and Louis G. Zachary, Jr. Mr. Chachas and Mr. Zachary will continue to have sole ownership of the voting interests in INYO Investors LLC. Subsequent to the filing of the Applications, however, INYO has modified the intended capital structure of INYO Investors LLC to add a class of non-voting stock, most of which will be held by Methuselah Advisors Cash Balance Plan and Trust. Methuselah Advisors Cash Balance Plan and Trust is a defined-benefit plan for employees of Methuselah Advisors LLC, and Mr. Chachas and Mr. Zachary are the principal participants in that plan. Mr. Chachas holds 68.48 percent of the accrued and allocable value of the plan, and Mr. Zachary holds 27.59 percent of the accrued and allocable value of the plan. All others hold less than 3.9 percent. Methuselah Advisors Cash Balance Plan and Trust will hold only non-voting stock in INYO Investors LLC. The parties hereby amend Section 5.ii of the Comprehensive Exhibit to the Applications to amend the ownership information for INYO Investors LLC to describe this change in its capital structure:

- 4. Exhibit A hereto sets forth a revised post-closing ownership diagram reflecting the above changes.
- 5. As included in the Applications, Scripps and ION and Scripps and INYO executed amendments to the Merger Agreement and Divestiture Asset Purchase Agreement, respectively, to provide for the possibility that INYO could acquire three additional stations from ION in the event that Scripps continued to own WPIX-TV at the time of closing of the instant transaction. On December 1, 2020, the Media Bureau granted Scripps' application to assign WPIX-TV to Mission Broadcasting, Inc., and Scripps expects to divest the station prior to the closing of the instant transaction. On December 11, 2020, Scripps notified INYO that it was exercising its option to terminate the amendment to the Divestiture Asset Purchase Agreement (attached hereto as Exhibit B). Accordingly, Scripps, not INYO, will acquire stations WPPX-TV (Wilmington, DE), KKPX-TV (San Jose, CA), and KPXM-TV (St. Cloud, MN). Exhibit C hereto sets forth a definitive list of stations to be acquired by INYO pursuant to the instant transaction.


