Request for Special Temporary Authority
to Remain Silent

Dear Mr. Horton:

This letter concerns the request you filed on March 6, 2008, on behalf of Pensacola Christian College, Inc. (PCC), for Special Temporary Authority to permit FM Translator Radio Station K217CW, Coos Bay, Oregon, to remain silent.

PCC's request states that K217CW went silent on March 1, 2008. PCC indicates that a brush fire on that date destroyed the building housing the station's transmitter and satellite equipment. It states that a temporary building has been built and some replacement equipment has been shipped. Accordingly, PCC requests authority to remain silent until all equipment has been delivered and installed. Finally the licensee's request includes the appropriate certification regarding Section 5301 of the Anti-Drug Abuse Act of 1988.¹

PCC's request will be granted. Accordingly, Special Temporary Authority is granted to permit FM Translator Station K217CW to remain silent for a period not to exceed 180 days from the date of this letter. **Notwithstanding the grant of this Special Temporary Authority, the broadcast license of K217CW will automatically expire as a matter of law if broadcast operations do not commence by 12:01 on March 2, 2009.**² See Section 312(g) of the Communications Act, 47 U.S.C. Section 312(g).



Finally, the station's silent status does not suspend the licensee's obligation to comply with all other relevant Commission rules, including the filing, when appropriate, of applications for renewal of broadcast license. Additionally, we note that it is imperative to the safety of air navigation that any prescribed painting and illumination of the station's towers shall be maintained. *See* 47 C.F.R. Sections 17.6 and 73.1740(a)(4).
