

## EXTRAORDINARY CIRCUMSTANCES AND ANTENNA PROPOSED

LICENSEE LOST THE HISTORICAL SITE AND EVENTUALLY RELOCATED. DELAWARE COUNTY ZONING WILL NOT ALLOW RELOCATION OF 6 TOWERS AND WILL NOT REZONE 90 ACRES FOR SUCH USE. ZONING WILL NOT ALLOW FACILITY CONSTRUCTION OF MORE THAN A SINGLE TOWER WHICH EXISTS CURRENTLY.

FORMER LANDOWNER WENT BANKRUPT AT THE HISTORICAL SITE. FACILITIES WERE DISMANTLED. DUE TO COVID COMPLICATIONS A NEW SITE WAS FOUND USING A WIRE ANTENNA. LICENSEE REQUESTS USE OF A WIRE ANTENNA 77.4 METERS (CALCULATED QUARTER WAVELENGTH 254 FEET) AND TRANSMITTER OPERATING AT 65 WATTS DAY AND 1 WATT NIGHT AS HAS PREVIOUSLY BEEN GRANTED. WIRE WILL SLOPE IN FENCED YARD to 18.28 M TO A STANDOFF AT THE FACILITY THEN PROCEED TO 2 POLES at THIS SAME HEIGHT. THE YARD IS FENCED WITH A WOODEN FENCE AT THE ORIGIN POINT. RF WILL NOT EXCEED OET GUIDELINES AND USE OF A NARDA RF METER WILL CONFIRM SAME. COORDINATES ARE 40-11-20.4 N AND 85-23-44.3 W. Street Address 900-908 W Powers Street Muncie, IN 47305.

LICENSEE HAS HAD SEVERAL ENGINEERING STUDIES OVER THE PAST YEARS AND HAS HAD AN ENGINEERING STUDY CONDUCTED BY MUNN REESE OF COLDWATER MICHIGAN (FORMERLY E HAROLD MUNN). THE STATION CAN RESUME OPERATIONS AT 600 WATTS WITH A QUARTER WAVE RADIATOR ONCE THE AM RULES ARE ADOPTED. THE ANTICIPATION OF THIS HAS BEEN MANY YEARS IN THE MAKING HOWEVER THE RULES HAVE NOT YET BEEN ADOPTED. THE LATEST COMMUNICATION INDICATES NEW AM RULES ARE ON HOLD.

LICENSEE WISHES TO KEEP THE FACILITY OPERATIONAL AND RETURN FACILITY TO IT'S FORMER STATUS ONCE THE PROPOSED AM RULES ARE ADOPTED.
