Dear Mr. Kennedy:

This is in reference to the request filed on December 17, 2020. Entercom requests a further extension of the STA originally granted on June 25, 2020, to continue operating ND at night with 0.48 kW as authorized by BP-20200810AAQ to allow time to file the required FCC Form 302 application.¹ In support of the request, Entercom estimates it will be able to file the application soon.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of the STA is hereby GRANTED, and Entercom

may continue to operate ND at night with a maximum of 0.48 kW, with no change to the licensed daytime 5 kW ND operation. Entercom must reduce the nighttime power or cease operation if complaints of interference are received, and use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **July 7, 2021**.
