### **Tolling request**

On Sept 11 2020 the Federal Communications Commission, or the FCC, released a public notice concerning translators and tolling requests under a provisions of extenuating circumstances.

Powell Meredith Communications Company, or PMCC, requests the tolling on three FM translators permits, which are- South Padre TX- K287BP Fac Id- 142717  
Gulfport MS- W270CS Fac id- 142760  
Wickenburg, AZ- K221GE-Fac Id- 14331  
**(See attachment of permits)**

### **Background-**

In 2003 PMCC applied for some 20 new FM translator permits under auction 83. In 2013 these three permits that are part of this tolling request, along with 5 others, for a total of eight came out in a MX list for engineering solutions to bi-pass an auction process with engineering settlements.

On June 2 2013, PMCC was approached by Scott Powell who was a FORMER owner, with an offer from a third party to process 8 permits in the PMCC account. PMCC declined the offer and I have provided proof of this to the courts which was accepted as fact by the courts. In a 2016 Federal court order the judge made it very clear that Meredith refused the third party processing proposal but the processor felt that Meredith was not the legal owner and encouraged the former owner to move forward despite Meredith's denial. In the court order it explains how the third party processor told the former partner of PMCC that my participation was not necessary to move forward in to processing these permits.

In a Dec of 2016, in a ruling that became a statement of fact, Federal Judge William Thurman in Salt Lake City UT made the statement as part of the records that Meredith REFUSED to process all 8 permits at this juncture. That is correct, at that point in time Meredith did refuse to process the stations and had made a conscious decision to wait for a fair and equitable auction process. The third party processor has provided 2 affidavits to the FCC and multiple affidavits to the courts claiming Meredith

lacked the knowledge to proceed forward with these processing these applications so they would turn in to a grant so therefore he processed these permits in the PMCC name for himself. Although its important to note that this story later on changed. None the less someone besides Meredith processed 8 new permits inside the PMCC account with my knowledge and I am left with three of those today.

At first Rockwell Media Services, via Morgan Skinner, admitted to processing these permits with an affidavit to the FCC but that story had changed, although FOIA records show these were paid for by Morgan Skinner and Rockwell Media . The end result is that these three permits as part of this tolling request were processed in July of 2013 and granted in January of 2016. Although this is where it gets tricky because they were granted in to the PMCC name but PMCC had no legal rights to them since they were already part of a bankruptcy estate while they were still applications. Still the end result was that 8 permits were processed in the PMCC account without my knowledge and permission and three of those still remain today which are part of this tolling request. The other five were stolen out of the FRN account with a forged power of attorney and forged APA agreement. PMCC was NEVER compensated for these as they went in to a bankruptcy estate where the lawyer stole all the funds from that account.

According to 3 court affidavits, as well as several more live court testimonies by the CTN, lawyer John Barlow claims that these three permits that are part of this tolling request were dismissed by the audio division on Dec 2 2015. Barlow then claims that he called up the audio division and had a phone call and had email conversations where he discussed his dilemma and then after those talks, he decided to declare bankruptcy to preserve the three remaining permits in the PMCC account. After the bankruptcy was filed, Barlow claims to have called up audio division to have the permits reinstated. From what PMCC can determine, one or two of the permits were dismissed and not all three but they were reinstated in December of 2015. One month later all three of the permits were granted in to the PMCC account in Jan of 2016. Still PMCC was never notified of the calls or emails with Barlow and the audio division, so we are still in the dark as to what and how these were processed granted and reinstated. All we have to go on is the court order which has been made in to a statement of fact anyway and assume that this is correct.

Even though the permits were in the PMCC name, as of Jan 2016, at this point in time they were not owned by PMCC. Yes CTN should have asked for a transfer of the ownership at this point but they did not but they were legally in control of the permits, not PMCC. PMCC did notify the FCC in NUMEROUS filings of this matter, we were not trying to hide the fact that we had lost official control of the stations.

In December of 2019, Judge William Thurman returned the three permits that are part of this tolling to PMCC. At this time though PMCC was only given 18 months by the audio division to build the permits. Granted had PMCC built these while they were under the courts ownership, I would have faced fines, sanctions and jail time for disobeying the automatic stay order of the bankruptcy law. In fact, PMCC did make efforts to start building one of the permits and the lawyer and owner of Community Translator Network hit PMCC with threats of various nature which included fines, sanctions and even threats of jail time. PMCC stopped all construction. At first I did not fully understand that I had lost the rights to the three permits but through repeated threats by CTN, and a court ruling in late late 2016, I finally understood bankruptcy law.

**Lawsuits involved with these three permits-**

March of 2014, The first lawsuit involving these three permits started in Washington County UT even before they were granted, this was Morgan Skinner, John Barlow, Rockwell Media and Community Translator Network VS PMCC, Amy Meredith and Scott Powell, lawsuit number- 140500250 Currently this lawsuit is still pending. At first PMCC lost this suit on a default due to a small mistake made by our lawyer but later on the judge over turned that default but during that default time PMCC was order by the courts to not process any more of these stations and not interfere with Barlow and Skinner continue to process these permits. This case involved hearings and depositions and was set for trail on Dec 10, 2015 but on Dec 2 2015 the FCC allegedly dismissed 2 or 3 of these permits and then before PMCC could go to court CTN declared bankruptcy because they say the needed to reinstate these three permits that are part of this tolling requests.

December of 2015 Community Translator Network declared bankruptcy- Community Translator Network Utah bankruptcy number- 2:15-bk-31245 At this point in time the three permits that are part of this bankruptcy were placed in to bankruptcy estate for CTN. PMCC asked for them to be removed but was denied.

April of 2016 PMCC and these permits were subject to another lawsuit, Community Translator Network VS Powell Meredith Communications Company- 2:16-AP-02073 which was an adversary lawsuit inside the Utah bankruptcy court.

June 2017- CTN bankruptcy was converted to a liquidation state after a request from the Dept of Justice under the US Trustee was made. The company then went to a court appointed Trustee. During this time the trustee and PMCC tried to work out an agreement for PMCC to turn over the official ownership of the three permits under the PMCC name to the bankruptcy courts. At this point in time these three permits were hit by more lawsuits in Texas.

July 2017, John Barlow of Community Translator Network files an appeal of the conversion to Judge Jill Parrish in Salt Lake City UT, John Barlow and Community Translator Network Vs Powell Meredith and the US Trustee 2;17-cv-00736. This was denied in February of 2018.

December 2017- Barlow Vs Powell Meredith Communications Company- 1;17-CV-00188 – This lawsuit ended in a dismissal and costs were taxed against the Plaintiff in August of 2018.

Skinner Vs Powell Meredith 1;17-cv-00187- This ended in August of 2018 with a dismissal of the lawsuit by Federal judge Sam Cummins.

August 2018- John Barlow Law and John Barlow attorney declares a personal no asset bankruptcy wipe out. PMCC and Rockwell and Morgan Skinner are listed as creditors and any claim that PMCC might have has was wiped out by a separate bankruptcy judge.

December 2019- out of frustration from dealing with the third party processor and his lawyer and the owners of CTN, the court appointed Trustee for the bankruptcy gave these three permits back to PMCC.

By March 2020 the covid outbreak hit and on June 10 2020 and I was diagnosed with covid and have proof of this if its needed and did not test negative until August 8 2020. During this time I quarantined because even though I was healthy during part of this time, I was still contagious to others. I also had to take off two months from my job. This was not a good time for me to be traveling around and building these stations because it would mean spreading covid around the US. I am negative now and

do donate plasma but there are side affects with that as well. Covid has also interfered with being able to get all the equipment tower sites and engineers to build these stations properly.

PMCC will most likely need to change some of the engineering specs of the permits as these stations were moved to different towers by an engineer that I didn't even know, or have even talked to and in fact to back up my statements Wisnieski has accused me of stealing his engineering. In these attacks he has admitted to have not working for me or PMCC but for Rockwell Media Services and this is the problem with the audio division allowing third party processing teams in to private FRN accounts, they may trying to be helpful but its really not. Recently I was unable to get back in to this account and I am unclear as to why but I do need to transfer the remaining two permits to a more secured account.

The engineer for the original 301 long form was Gene Wisnieski and I didn't order this engineering and I didn't approve this engineering, nor did I let this engineer in to my account and in fact this engineer claims that I stole his engineering and tried to file a report against me. Wisnieski is an FCC engineer but mostly for World Radio link and never for PMCC. I have never spoken with Wisnieski and I am told some of the engineering that he has produced is not realistic to build. I am not even certain that this engineer actually filed these long form 301 applications although his name is on the long forms but that means nothing, so was my name and my ex husband Scott Powell's and neither of us knew about this.

In order to build these a real broadcast engineer is going to have to look at these and fix the engineering specs. Although the engineer claims he was hired by Morgan Skinner he also filed a claim in the bankruptcy saying he was never paid. PMCC did NOT allow Wisnieski in to the account so I have no idea how he even entered that account unless he was given access by the CORES dept like others including John Barlow, as well as Morgan Skinner, Lavon Randall and Ray Carpenter some how accessed this account.

I do feel these reasons as well as covid, I feel I should be entitled to extra time to build these station at least an extra 6 months since the State of Texas where I reside officially went in to a partial shut down from March to September of 2020.

I have recently sold one of these stations but it has not been approved or closed as of yet. The other I have made plans to build them and have found two tower sites and am in the process of buying equipment but at this point in time it may be hard to travel.

For the reasons of covid restrictions and multiple lawsuits that have delayed the ability of PMCC to construct, PMCC prays for more time to construct.
