Dear Mr. Davis:

This is in reference to the request filed on January 8, 2021. CLI requests an extension of the STA granted on July 17, 2020, to continue operating with parameters at variance to allow time to resolve nighttime reradiation problems caused by construction of a nearby 180 foot tower by Motorola Solutions, Inc. (MSI).¹ In support of the request, CLI states that additional time will be required for MSI to assist CLI in resolving all problems.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of the STA IS HEREBY GRANTED, and IHM may continue to operate with parameters at variance from its licensed facilities and/or reduced power while maintaining all day and night monitor points within licensed limits. IHM must reduce power or cease operation if complaints of interference are received, and use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310. IHM must

submit an e-mail to my attention to note the date an FCC Form 302 application was filed to update all operating parameters, or to note the date the station was able to resume licensed operations per BL-20040303ACT with negligible changes.

This authority expires on **July 25, 2021**.
