Dear Mr. Denning:

This is in reference to the request filed on February 2, 2021. RLH requests a further extension of the STA granted on January 15, 2020, to continue operating with parameters at variance to allow time to file the required FCC Form 302 application to cover BP-20201103AAN to correct the site coordinates, and to update all operating parameters.¹ In support of the request, RLH stated that all the extensive repairs have been completed, and that additional time is needed to file the application.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.


Accordingly, the request for extension of the STA IS HEREBY GRANTED, and RLH may continue to operate with parameters at variance and reduced power to maintain all nighttime monitoring point values within licensed limits. RLH must reduce power or cease operation if complaints of interference are received, and use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure

guidelines. *See* 47 CFR § 1.1310. RLH must submit an e-mail to my attention to note the date the application was filed.

This authority expires on **August 8, 2021**.
