Dear Mr. Kaufman:

This is in reference to the request filed on February 8, 2021. BRE requests a further extension of the STA granted on July 23, 2012, to continue operating from the KDNL(TV) transmitter site to allow time for our staff to review the pending construction permit application BP-20210209AAF.¹ In support of the request, we noted that the application proposes to use the existing registered tower (ASRN # 1003524) located at the coordinates shown below.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of the STA is **HEREBY GRANTED**, and BRE may continue to operate daytime with the following facilities:


¹¹ KXEN(AM) is licensed for DA operation on 1010 kHz with 50 kW (day) and 0.5 kW (night), and BP-20210209AAF proposes to use the existing tower located at the STA site using reduced power levels.

Frequency:	1010 kHz
Operating hours:	Unlimited
Operating power:	0.35 kW (day), 0.125 kW (night)
Antenna:	74.2 m vertical wire supported on face of self-supporting tower located at KDNL(TV) studios
Radiator height:	90°
ASRN:	1003524

BRE must reduce power or cease operation if complaints of interference are received, and use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **September 10, 2021**.
