Request for tolling

Dear Mr. Johnson:

On March 15, 2021, we received your request on behalf of Blue Sky Broadcasting, Inc. (BSB), for tolling of the construction deadline for a construction permit for FM Station KPND(FM), Deer Park, Washington (File No. BPH - 20170620AAY). That construction permit was granted on April 20, 2018, for a three-year term, expiring April 20, 2021.

BSB's tolling request is based on a condition precedent on the permit. This request falls within one of the criteria for tolling, and is granted.<sup>1</sup> Pursuant to section 73.3598(c) of the rules, because the request was filed more than 30 days from the date that the tolling event occurred (grant of the application), we look back 30 days from the date of filing to determine the effective date of tolling. Therefore, we have placed a note in the station's record in our public database indicating that the request has been granted, effective February 15, 2021.

Grant of the request is subject to the following conditions:

Tolling is effective as of February 15, 2021. Once tolling ends, 2 months, 6 days will remain on the permit.

Tolling will remain in effect until August 9, 2021, absent earlier resolution of the condition on the permit. If the matter is not resolved within 6 months, BSB must file a status report by September 15, 2021, and at six-month intervals thereafter, requesting continued tolling treatment.

BSB also must notify us within 30 days of the condition being resolved.

When tolling ends (either because BSB has not filed a request for continued tolling or because the matter has been resolved) we will calculate a new permit expiration date by adding the remaining 2 months, 6 days.
