Dear Applicant:

This is in reference to the request filed April 12, 2021, on behalf of Clark Media, LLC ("CML"). CML requests special temporary authority ("STA") to operate station WATX(AM) from an alternate site location with a temporary long-wire antenna.¹

In support of the request, CML states that ownership of the WATX(AM) transmitter site has recently changed and the new site owner has denied the WATX(AM) licensee access to its licensed transmitter site. The station went silent on June 25, 2020 and therefore the station's license will automatically expire if broadcast operations do not commence by 12:01 a.m., June 26, 2021. Thus, WATX(AM) requests STA to relocate to a different location and operate with a temporary long-wire antenna.

Specifically, WATX(AM) proposes to operate from a site located 1.88 kilometers (1.17 miles) from its currently licensed site. Operation is proposed with a reduced daytime power of 0.25 kilowatt and a reduced nighttime power of 0.076 kilowatt employing a 190 foot (57.9 meters) long-wire antenna supported between two 35-foot telephone poles. The long-wire antenna will be suspended 20 feet above ground level.

STA requests which involve a change in transmitter site must include four critical elements: (1) Loss of the licensed site must be beyond the licensee's control; (2) STA facilities must continue to provide service to the licensed community; (3) STA facilities must maintain, as closely as practicable, the licensed service area² without extending it; (4) STA facilities cannot involve the construction of towers intended for permanent use by the station requesting the STA.

Accordingly, the request for STA is GRANTED. Station WATX(AM) may operate with the following facilities:

It will be necessary to further reduce power or cease operation if complaints of interference are received. WATX(AM) must notify the Commission when licensed operation is restored. WATX(AM) must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **October 11, 2021**.

Notwithstanding the grant of this STA or the expiration date specified herein, the station's license will expire as a matter of law if broadcast operations do not commence by 12:01 a.m., June 26, 2021. *See* Pub. Law No. 104-104, 110 Stat. 56, Section 403(1)(1996) and *Order, Silent Station Authorizations*, FCC 96-218 (released May 17, 1996). *See also* *Public Notice, Expedited Processing of Applications Filed by Silent Stations*, DA 96-818 (May 22, 1996). The licensee must notify the Audio Division immediately upon resumption of broadcasting.

STA Advisory: Section 309(f) of the Communications Act of 1934, as amended, authorizes the Commission to grant STA in cases of "extraordinary circumstances requiring temporary authorizations in the public interest and when delay in the institution of the temporary operations would seriously prejudice the public interest." However, Section 309(f) is not a means by which a licensee/permittee may circumvent established processing procedures which require the filing of an application, nor is it a means by which a broadcaster may enhance his facility or make operation more convenient for the broadcaster. Stations operating with less than licensed facilities under temporary authorities can be viewed as receiving the benefit of a larger protection area than that in which they are currently providing service.

Accordingly, Special Temporary Authorities by nature are to be temporary and are not intended for extended use. Licensees of stations operating under temporary authorities are reminded that timely restoration of permanent facilities is the responsibility of the licensee and should be undertaken expeditiously. Any request for extension of special temporary authorities carries an increased burden with each subsequent request.


Therefore, requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward

restoration of licensed operation; or

- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.
