If you also request cancellation of Construction Permit BPH-20180410AAG, you can file the application as a minor change to the licensed facility (BLH-

20010507AAX). This “new” app will be granted with a 3 year expiration date and you will not have to worry about “building” the facility or filing the license application before the May 16, 2021 expiration date of the “2018 CP.”

I am assuming that you are NOT changing the channel, class or city from the “2018 CP”. Therefore, please note, the RSV for Channel 272C in Wendover, NV will remain valid so DO NOT file the “new” minor change application as a one-step proposal.

This was the email I sent to Mr. Wisniewski.

Mr. Wisniewski:

Regarding the license application (File No. 0000143323) for KVVUW(FM),  
Wendover, NV (Fac 84328). These are the issues we discussed on the phone:

1. There is a red light issue on FRN 0024806911 that must be resolved.
2. The proposed tower was a 50 meter unregistered tower. In the exhibit to the license application it is stated that the tower is 37.8 meter registered tower (ASRN 1226395). This change cannot be made on a license application. It requires a construction permit application.
3. In addition, the site elevation of the registered tower differs by 11.3 meters from that specified in Construction Permit BPH-20180410AAG. Specifically, the registered tower has a site elevation of 2521.9 meters and the construction permit specified a site elevation of 2533.2 meters. This change in site elevation would probably change at least one (maybe more) of the antenna height figures by more than the 4 meters down/2meters up allowed by 47 C.F.R. Section 73.1690. Therefore, a construction permit application will also be required for this change.
4. There is a discrepancy in the coordinates. Specifically the license application specifies coordinates of 41 7 19.1 NL, 114 34 5.3 WL. ASRN 1226395 specifies coordinates of 41 7 19.1 NL, 114 34 5.2 WL

Please note, on any construction permit application you file, if you propose 100 kW the HAAT cannot exceed 600 meters pursuant to 47 C.F.R. Section 73.211.
