DECLARATION OF LINDA BRINCKERHOFF

Linda Brinckerhoff states as follows:

I am the president of Golden Feathers Ministries, Inc., licensee of KRGR-LP, Paradise, California. This statement is submitted in response to the Notification of License Expiration from the Chief of the Media Bureau's Audio Division, dated April 16, 2021, directed to KRGR-LP.

Due to the severe disruption to the conduct of normal life and business caused by the Camp Fire in and around the community of Paradise, California, KRGR-LP went off the air on November 4, 2019. The station resumed broadcasting on March 28, 2020, and has been operating continuously since that date except for sporadic brief periods lasting no more than a day or two when there are routine safety blackouts by the electric power company. A resumption notice has now been filed in CDBS. The resumption notice was not timely filed because of miscommunication between station personnel and counsel.

The station has been operating since March 28, 2020, with its authorized parameters at its authorized antenna site at 39-45-12 north latitude and 121-37-7 west longitude.

Attached are photographs of the currently installed operating plant for the station, including the antenna structure, studio facilities, and the installed EAS unit. Also attached is a copy of a bank statement from April 2020, showing payments made for music copyright fees.


The station operates on the premises of the Paradise Adventist School. The School does not charge the station for rent or utilities. Consequently there are no financial records to show payment for rent or electricity.

KRGR-LP is a very small low power station. It is staffed entirely by volunteers and has no expenses other than music copyright fees. Hence, other than for copyright fees, there are no significant operational financial records.

Many months after the Camp Fire, life is still not back to normal for many of the residents and institutions in Paradise. Some of the licensee's principals lost their homes in the fire. Returning the station to the air and keeping it on the air have been difficult tasks to accomplish under difficult circumstances. In spite of those difficulties, Golden Feathers Ministries is committed to continuing to provide a radio service to the community of Paradise.

KRGR-LP has not been silent for any period of 12 consecutive months and is not subject to expiration of its license pursuant to Section 312(g) of the Communications Act.

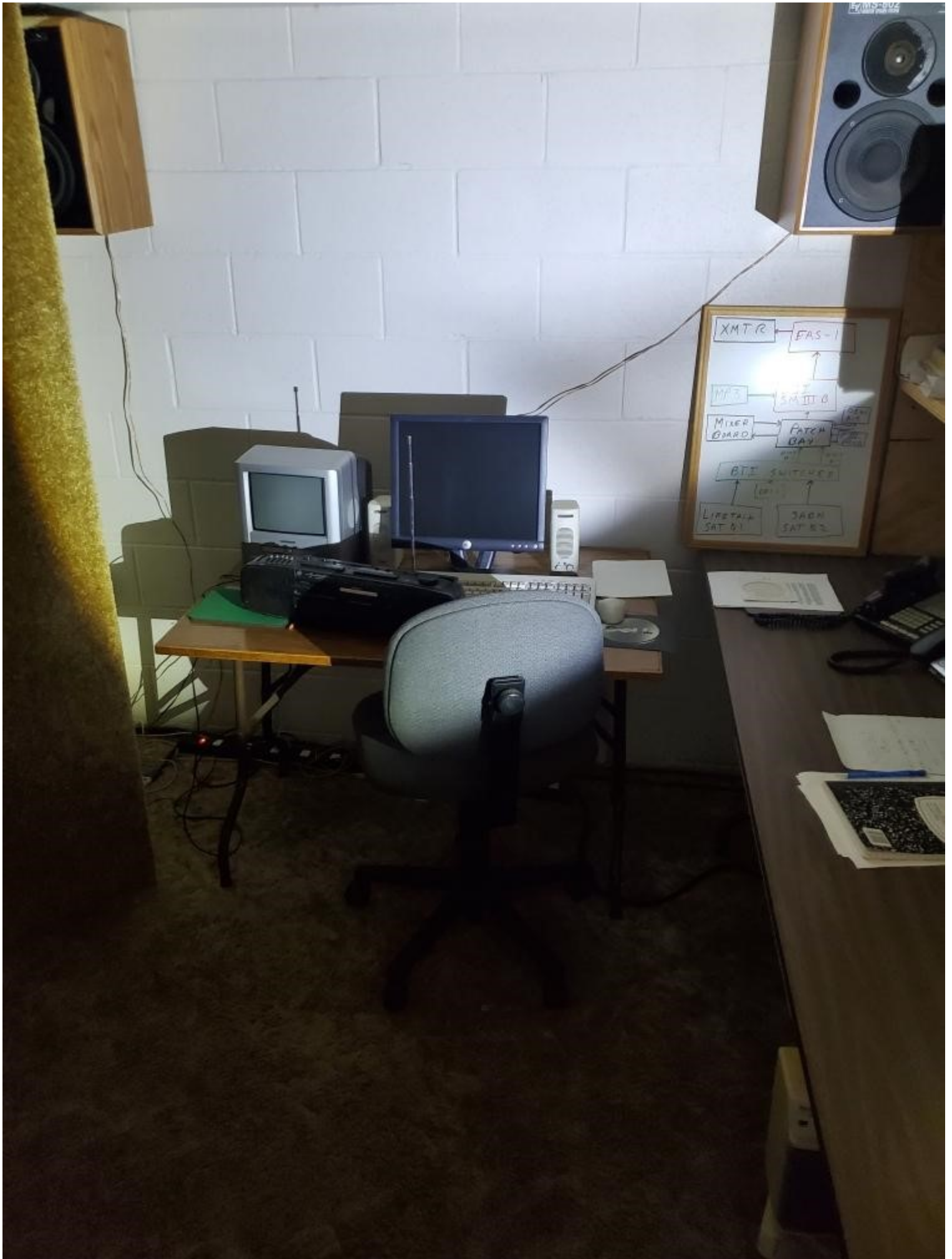

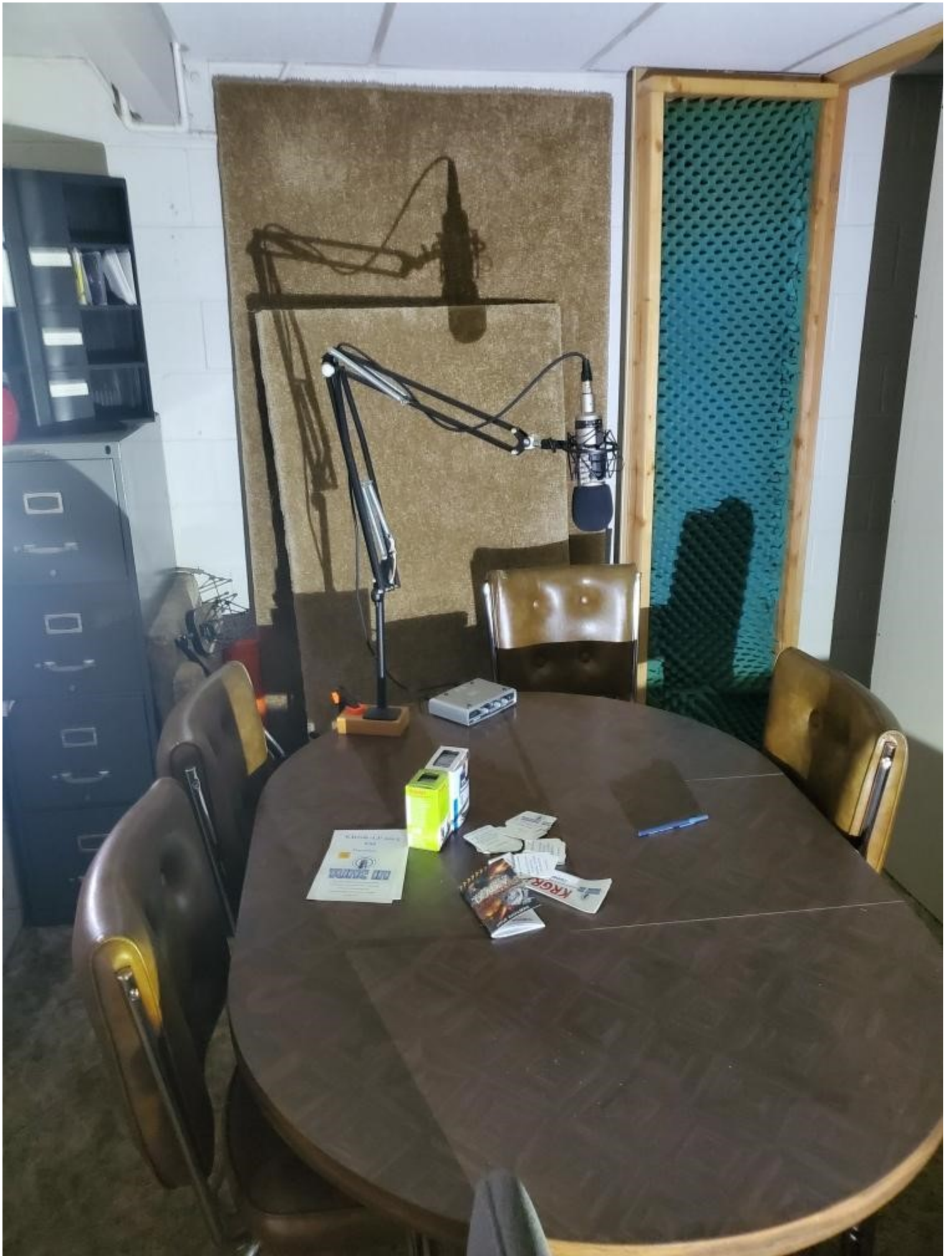
