Dear Mr. Manarchuk:

On September 21, 2020, October 1, MRP Communications and Consulting, LLC, the licensee of Radio Station WVBF(AM), Middleborough Center, Massachusetts, FCC Facility ID No. 63404, requested a Special Temporary Authority to operate the Station at reduced power. The request was predicated on damage to the Station's modular main transmitter and on the need for a replacement or repaired r-f output module.

(The transmitter has four such modules. Each module contributes to the aggregate r-f output power that the transmitter generates. If necessary, the transmitter can operate with less than a full complement of such modules.)

By letter dated October 1, 2020, the Audio Division granted the licensee's request for an STA. See FCC File No. BSTA-20200921ABX.

The grant letter required, among other things, that the licensee must notify the Commission when the licensee has restored operation with the Station's licensed parameters.

The licensee has informed me that the Station resumed operation at its licensed r-f transmitter output power on October 10, 2020.

Please advise whether this message is sufficient to discharge the licensee's obligation to notify the Commission when licensed operations

have resumed, or whether the Audio Division requires a letter, printed on paper and physically signed, and submitted via the Office of the Secretary.
