

**PETITION TO DISMISS CONSTRUCTION PERMIT FOR**  
**WCKG-AM, ELMHURST, ILLINOIS**

Comes now, Metro North Communications, Incorporated, (hereinafter 'Metro') as Licensee of WLAK-AM, New Holstein, Wisconsin (1530 Khz.), by its President, Mark Heller, with a 'Petition to Dismiss' the Construction Permit for Standard Broadcast facility, WCKG-AM, Elmhurst, Illinois, owned by DUPAGE RADIO, LLC. (hereinafter 'DUPAGE RADIO')

Whereas, DUPAGE RADIO had previously been granted a Construction Permit, which expired in early June 2019, without any effort to construct same, and then re-applied for same at the moment of expiration, which in Metro's opinion constituted 'tolling'. Metro now respectfully demands that it be cancelled, for cause.

Metro has been notified, and confirmed that DUPAGE RADIO has now sold off its tower site, including its ground system. Already one of the two towers has been totally demolished and removed from the property, which it no longer owns or controls.

In their most recent filing, for an STA, (BSTA-20210316AAG) (*granted 3/22/21*), in its filing, DUPAGE RADIO declares under penalty of perjury in Exhibit 17, "The Tollway has exercised Eminent Domain, and we are unable to use our licensed system."

Today, WCKG-AM is operating with a long wire antenna at a power of 190 watts. It's programming schedule has been sporadic, as has its FM translator. DUPAGE RADIO was paid handsomely for this parcel. They did not protest, nor ask for an appeal, but rather they cashed the check.

**CONCLUSION**

The Commission must concur with Metro North Communications, Inc. that the current Construction Permit for WCKG-AM must be cancelled, immediately. It simply is 'null and void' and no longer able to be built.


In fact, the Public Interest, Convenience and Necessity would be well served by canceling this Construction Permit, so that Metro may file to amend its WLAK-AM, New Holstein, WI facility for a power increase.

The Public's Interest, Convenience and Necessity are **NOT** served (*emphasis added*) by maintaining this Construction Permit, which specifically specifies a tower which has been demolished, a ground system which has been removed, and with a proposed tower site, which is now part of the Illinois Tollway System. DUPAGE RADIO no longer controls this parcel on their application. To repeat, "We are unable to use our licensed system."

Now, therefore, Metro North Communications, Incorporated respectfully requests that the Current Construction Permit of Standard Broadcast Facility WCKG-AM, for File Number BP-20190604AAV be CANCELLED, for reasons stated above.


